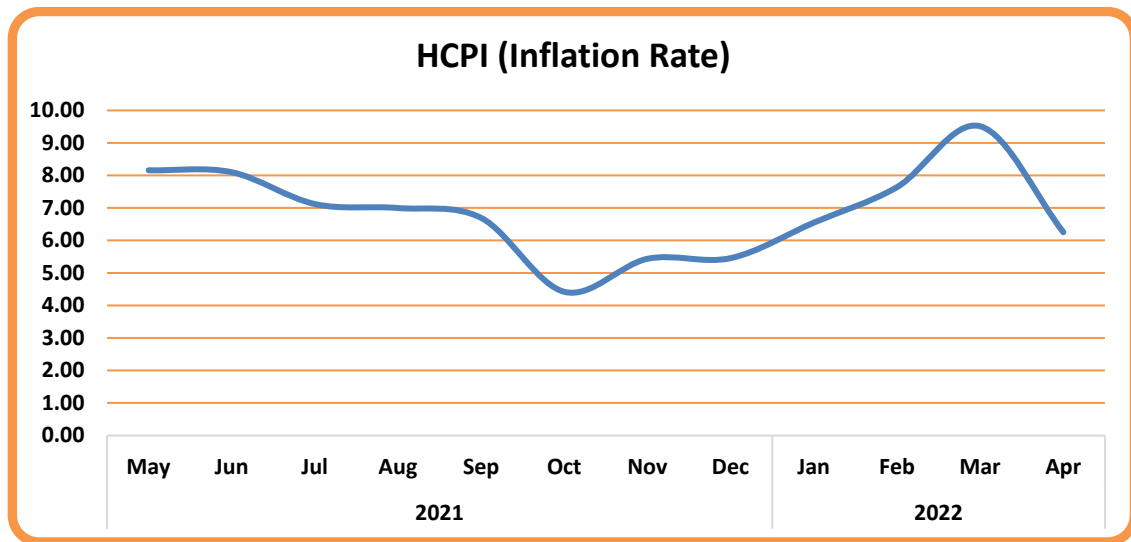

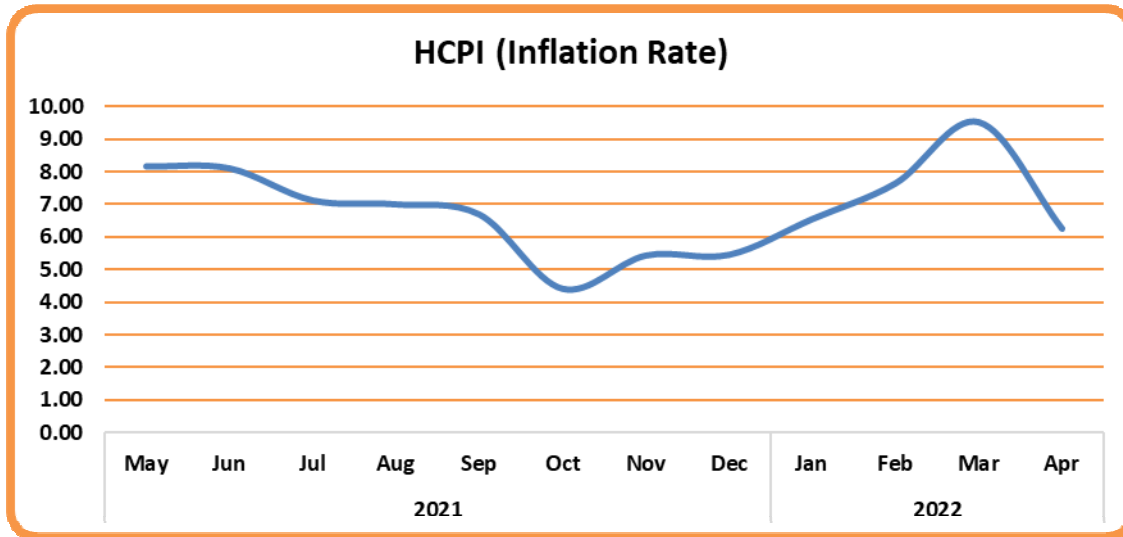

The Liberia Financial Statistics (LFS) is a bi-monthly database publication by the Central Bank of Liberia (CBL). It is mainly intended to meet the research needs of the academia, the business community, policy makers and development partners. The publication is made six times a year with the first, second, third, fourth, fifth, and sixth editions appearing in February, April, June, August, October, and December, respectively. The data frequency is monthly and are expressed in thousands or millions of Liberian or United States dollars with each publication covering the period of three years.

The graph on the cover page represents the Harmonized Consumer Price Index (Inflation Rate) covering the period May 2021 to April 2022.

The Central Bank of Liberia remains grateful to its many data providers, both in the public and private sectors, whose cooperation in providing the required data has helped to continuously make this publication successful. The CBL assures all data providers that data provided will only be used for statistical purpose to inform research and policy decisions.
